COMMISSION STAFF'S POST-HEARING REQUEST FOR INFORMATION
TO NAVITAS KY NG, JOHNSON COUNTY GAS COMPANY, INC.,
AND B & H GAS COMPANY

Navitas KY NG (Navitas KY), Johnson County Gas Company, Inc. (Johnson County), and B & H Gas Company (B & H) (collectively, Applicants) pursuant to 807 KAR 5:001, are to file with the Commission an electronic version of the following information. The information requested herein is due on April 5, 2021. The Commission directs Applicants to the Commission's March 16, 2020 and March 24, 2020 Orders in Case No. 2020-00085¹ regarding filings with the Commission. The Commission expects the original documents to be filed with the Commission within 30 days of the lifting of the current state of emergency. All responses in paper medium shall be appropriately bound, tabbed, and indexed. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Applicants shall make timely amendment to any prior response if Applicants obtain information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Applicants fail or refuse to furnish all or part of the requested information, Applicants shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Applicants shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to the Gas Purchase Agreement between Hall Stephens and Hall and Navitas KY. Clarify which NYMEX index is indicated in the gas contract formula provided of NYMEX plus \$2.00.
2. Using the Gas Purchase Agreements between Hall Stephens and Hall and B&S Oil and Gas and Navitas KY, based on the most current gas cost information available, provide an example calculation for each company showing how the parties intend the gas from Hall Stephens and Hall and B&S to be priced to Navitas KY.
3. Provide a copy of any existing maps of the B & H and Johnson County systems.
4. Provide any materials that document Navitas KY's procedures, including its training and testing materials, for the qualification and certification of meter testers.
