NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

(Complete All Shaded Areas and Check Applicable Boxes)

In accordance with 807 KAR 5:001, Section 8, <u>Conexon Connect LLC</u> gives notice of its intent to file an application for designation as an Eligible Telecommunications Carrier on later than January 6, 2021 and to use the electronic filing procedures set forth in that regulation.
