OPENING ORDER

Riggs Construction, LLC (Riggs) has been named as a party to an investigation before the Kentucky Public Service Commission (Commission) for allegedly violating the Kentucky Underground Facility Damage Prevention Act (Act).¹

Pursuant to KRS 278.495(2), the Commission has jurisdiction to regulate the safety of natural gas facilities in Kentucky and to enforce minimum federal pipeline safety standards. Under the Act, the Commission has authority to investigate and assess civil penalties for any violation of the Act that results in excavation damage to an underground facility used to transport natural gas or hazardous liquid subject to federal pipeline safety laws, 49 U.S.C. § 60101, et seq. Any person who violates any provision of the Act is subject to assessment of a civil penalty in the amount of \$250 for the first offense, no more than \$1,000 for the second offense within one year, and no more than \$3,000 for the third and any subsequent offense. Additionally, any person whose violation of the Act results in damage to an underground facility containing any flammable, toxic, corrosive,

or hazardous material or results in the release of any flammable, toxic, corrosive, or hazardous material is subject to an additional penalty of up to \$1,000.

Following receipt of a report of excavation damage to its underground gas pipeline from an operator, Commission Staff (Staff) conducted an investigation and prepared an Incident Report, a copy of which is attached to this Order as an Appendix. In its Incident Report, Staff cites Riggs for violation of the following provision of the Act:

KRS 367.4911(1)(a) – Each excavator, or person responsible for an excavation, planning excavation or demolition work shall, not less than two (2) full working days nor more than ten (10) full working days prior to commencing work, notify each affected operator of the excavator's intended work and work schedule. Contacting the applicable protection notification centers shall satisfy this requirement.

Based on its review of the Incident Report and being otherwise sufficiently advised, the Commission finds prima facie evidence that Riggs violated the Underground Facility Damage Prevention Act. The Commission further finds that a formal investigation into the excavation damage incident should be conducted.

IT IS THEREFORE ORDERED that:

- 1. Riggs shall submit to the Commission, via email sent to PSCED@ky.gov with the case number of this proceeding in the subject line of the message, a written response to the allegations contained in the Staff Incident Report within 20 days of receipt of this Order.
- 2. Any partnership, corporation, or business entity (including a limited liability company) must be represented by an attorney licensed to practice law in Kentucky, and such representation includes the filing of papers with and appearances at hearings before the Commission.

- 3. An individual may submit a response to the allegations contained in the Staff Incident Report without the representation of an attorney.
- 4. The Staff Incident Report 43492 in the Appendix to this Order is made a part of the record in this case.
- 5. Please note that notice of a hearing to be held in this matter will be mailed to Riggs once proof of service is received by the Commission. Parties who fail to appear after service will be subject to entry of a default judgment against them.

INVESTIGATION

A review of LT...0213 revealed the ticket was obtained at 08:09 and the positive response indicates the facilities were marked with a conflict (See Attachment 2 & LT Summary). *Note:* 811, Carly Dunsmore, stated that the Positive Response notation "Does conflict" indicates that the Operator has facilities in the area needing marked and the Operator marked the underground facilities as noted on this LT.

On 04/29/21 an attempt to contact the Excavator at 606-393-5171 resulted in a message stating the number is no longer in service. *Note:* The LT lists Mr. Riggs address as 929 N. 3rd St. Ironton, OH 45638, phone number 606-831-3385.

On 04/29/21 Mr. Riggs was contacted at 606-831-3385. Mr. Riggs stated that the area was located, but Columbia's locate company was unable to find the service, therefore Columbia attempted to locate the service with no success. Mr. Riggs stated that all parties involved knew he was digging and no one informed him that he need to stop.

On 04/29/21 the Operator, Columbia's James Rice, via email, provided the following documentations:

- · Email with screen shot of Gas Lost:
 - <u>Email:</u> Mr. Rice states in the email that Mr. Rice confirmed with the locator that Mr. Riggs was informed not to excavate and the plant crew needed to come out and locate. *Note*: The "Do not dig" is documented in the Audit History for LT...0213 dated 03/30/21 at 3:13 pm see summary below and Attachment 3.
 - Gas Lost: Indicates that a Columbia employee was across the road from the incident location on another call when Mr. Riggs damaged the service line. Mr. Riggs was advised not to dig without markings, Mr. Riggs knew the LT was not due and Mr. Riggs knew not to dig. Note: Mr. Rice, via telephone, stated this note was written on the incident date and the conversation documented by

Columbia's Service Technician not to dig occurred before the damage.
