In accordance with 807 KAR 5:001, Section 8, <u>Cumberland Connect LLC</u> gives notice of its intent to file an application for designation as an Eligible Telecommunications Carrier on later than January 29, 2021 and to use the electronic filing procedures set forth in that regulation.
