SITING BOARD STAFF'S POST-HEARING REQUEST FOR INFORMATION TO RHUDES CREEK SOLAR, LLC

Rhudes Creek Solar, LLC (Rhudes Creek Solar), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on January 21, 2022. The Siting Board directs Rhudes Creek Solar to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the

preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Rhudes Creek Solar shall make timely amendment to any prior response if Rhudes Creek Solar obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Rhudes Creek Solar fails or refuses to furnish all or part of the requested information, Rhudes Creek Solar shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Rhudes Creek Solar shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- 1. Provide a copy of the cumulative environmental assessment required to be submitted pursuant to KRS 224.10-280, or direct the Siting Board to the portions of the record that include the information required by that assessment.
- 2. Provide any written communications or reports relative to this project that were directed to, or received from, the U.S. Department of Fish and Wildlife. Provide

these whether made through a third party such as the Army Corps of Engineers, or carried out directly with Rhudes Creek Solar representatives.

3. Provide a verification of the accuracy of the tax rates table provided by witness Dr. Paul Coomes in his report found in the Application, Attachment K, dated June 9, 2021, at page 5. If it is not accurate, provide a corrected table and any revised conclusions required by the correction.
