As the Chairman of the Kentucky Public Service Commission (PSC), I also serve as the Chairman of the Kentucky State Board on Electric Generation and Transmission Siting (Siting Board). Therefore, it is my duty to inform you that, on February 7, 2022, the Siting Board received an application from Bluebird Solar, LLC requesting a certificate to construct an approximately 90 megawatt merchant electric solar generation facility in Harrison County, Kentucky.

The permanent members of the Siting Board are myself and the other members of the PSC; the Secretary of the Energy and Environment (or her designee); and the Secretary of the Economic Development Cabinet (or his designee).<sup>2</sup>

In addition to the permanent members of the Siting Board, pursuant to KRS 278.702(1)(d)(1), one of the Siting Board ad hoc members is the chairman of the planning commission with jurisdiction over the area in which the facility will be located. Based on the facts as presented in the application, you will serve as one of the ad hoc Siting Board members as the Chairman of the Harrison County Planning and Zoning Commission.

Pursuant to KRS 278.710(1), the Siting Board is required to issue its decision granting or denying the application within either 120 days or 180 days, if a local public hearing is requested.
