Dear Mr. Phillips,

This letter is in response to an email you sent which was recently discovered by the filing department for the Kentucky Public Service Commission (Commission). It was by mere chance that this email was located. The email does not comply with proper filing procedures and would in normal circumstances be considered lost and not received.

It was determined that the email you sent was intended to be considered a response in the above case. The Division of Inspections (DOI) is well within its right to request that the Commission find the response inadmissible due to procedural error and the untimely filing. In the interest of providing this entity an opportunity to be heard, DOI has decided not to object to the inclusion of the response.

HOWEVER, all future filings must be submitted in accordance with proper procedure. JRP Utility Construction, Inc. (JRP Utility) shall submit all future filings via email, sent to PSCED@ky.gov, with the case number of this proceeding in the subject line of the message. All evidence that JRP Utility would like to present at the hearing to the Commission shall be filed no fewer than 10 days before the hearing. The failure to follow the proper procedure could lead to filings being deemed undiscoverable.

Additionally, any partnership, corporation, or business entity (including a limited liability company) must be represented by an attorney licensed to practice law in Kentucky, and such representation includes the filing of papers with and appearances at hearings before the Commission. Nonappearance at the hearing could result in the entry of a default judgment against JRP Utility.
