A virtual informal conference ("IC") was conducted on June 4, 2021. Attached is a copy of the attendance roster

The purpose of the IC was to discuss the deficiencies that were noted following Commission Staff's (Staff) review of Delta Natural Gas Company, Inc.'s (Delta) May 28, 2021 application for an adjustment in rates.

At the outset of the IC, Delta pointed out that its farm tap customers formerly served by Peoples Gas pay the same rate as Delta's other farm tap customers, not different rates as stated in the deficiency notice. Delta also provided Staff with a revised customer notice, which was reviewed by all present. Staff agreed the revised customer notice, with one minor revision, cured all noted deficiencies. The possibility of a deviation permitting Delta to publish the revised notice on its website and post it in its offices was discussed.

There being no further discussion, the IC was then adjourned.
