V. <u>COMPLAINANT'S COMMENTS AND DISAGREEMENTS REGARDING</u> <u>CONTENTS OF INFORMAL CONFERENCE MEMORANDUM OF</u> <u>SEPTEMBER 1, 2021</u>

Comes the Complainant, Joe A. Browder, Jr., and pursuant to the letter of September 1, 2021 of Ms. Linda Bridwell, P.E., Executive Director which is attached to Memorandum of same date and directing that any comments be made within five days of receipt of the letter and Memorandum, now state, in opposition to the content of the Memorandum that the content is incomplete and does not fully and accurately reflect the discussions having taken place during the Informal Conference of September 1, 2021, specifically, but not limited to:

The Memorandum does not mention the fact that counsel for LG&E began by essentially stating LG&E's Answer of July 12, 2021, followed by an "offer to dispense with the \$250.xx purportedly owed to LG&E" by me, the Complainant. The Memorandum does not mention the fact that I stated, or attempted to state that all assertions made by LG&E were refuted by facts and/or Statutes in my Reply of July 16, 2021 (filed July 19, 2021) and that removal \$250.00 debt was insufficient; but that I was also entitled to reimbursement of the majority of the \$246.84 paid after I moved, except for the portion up to 3 days after I moved out on February 16, 2021, or February 19, 2021; and in my belief reimbursement for costs expended in litigation of this case. The Memorandum failed to mention that counsel for LG&E stated that a "meter reading occurred at my unit on February 10, 2021 and that the estimated meter reading on March 11, 2021 was
