Supplemental Request for information to Russellville Solar, LLC

Please consider the following the Supplemental Written Request for information to Russellville Solar, LLC, following the Order Entered by the Kentucky Public Service Commission dated 03/17/2022, and the attached appendix. This Supplemental Written Request for information is from the Vick Family Trust involving a 120 acre farming tract bordered completely on the western and southern sides by the proposed solar farm.

It is abundantly clear to everyone that following the Response to First Request for information from Russellville Solar, LLC, dated 04/28/2022, and the Environmental Assessment provided to the Tennessee Valley Authority that there is no need whatsoever for this solar project in Logan County, Kentucky. There maybe a need for publicly traded companies in Warren County, Kentucky or Sumner County, Tennessee, but the submitted application clearly shows that there is no benefit whatsoever for the citizens of Logan County, Kentucky. There is clearly a No Needs Bases for the Kentucky Public Service Commission or the Tennessee Valley Authority to approve this proposed project and completely destroy prime farm cropland in Logan County, Kentucky.

It is regretful that Russellville Solar, LLC, in its Response to First Request refused to answer any of the 18 questions requested by the Vick Family Trust in a letter dated March 19, 2022. This fact along with the knowledge from the Response to First Request note that only days ago did Russellville Solar, LLC, c/o Community Energy Solar of Radnor, Pennsylvania, through Silicon Ranch of Nashville, Tennessee, begin to contact local public officials in Logan County, Kentucky, concerning major portions of this proposed project. It is clear from this submitted information to the Kentucky Public Service Commission and the Tennessee Valley Authority that Russellville Solar, LLC, is not aware, at all, of the local conditions and major challenges of this dangerous project to the prime cropland of Logan County, Kentucky. It is clear from the Response to First Request that Russellville Solar, LLC, of Radnor, Pennsylvania, can not and is not prepared to attempt solar construction on the most sensitive prime crop farmland in the United States.

It can clearly be seen to anyone from the Response to First Request and the Environmental Assessment submitted by Russellville Solar, that this proposed project will create a huge economic burden to the citizens of Logan County, Kentucky. It is clear that by taking thousands of prime crop farmland out of production, potentially forever, is a huge economic drain to Logan County, Kentucky. The fact that no maintenance plan has been submitted for this proposed project and the fact that no decommission plan is in place for this very dangerous project is enough reason to ask the Kentucky Public Service Commission to not allow this useless venture to completely destroy prime crop farmland. This request for construction is not by citizens of Logan County and not by citizens of Kentucky but by a corporation foreign to Kentucky and its economic interests.

Given these simple basis facts of 1) No Need Bases for this project to be constructed 2) Russellville Solar's clear inability to understand the dynamics of construction on this prime crop farmland 3) The huge economic burden this project will create in Logan County 4) The citizens of Logan County are not requesting this dangerous project, we would hereby request that the Kentucky Public Service Commission deny the application of Russellville Solar, LLC, to construct this project in Logan County, Kentucky.
