ORDER

The Commission, on its own motion, finds that the Order entered on February 24, 2022, should be amended. The Commission further finds that because the February 24, 2022 Order closed this case, the case should be re-opened for the limited purpose of correcting Appendix A to the February 24, 2022 Order.

On February 24, 2022, the Commission entered an Order approving the rates recommended by Commission Staff in its January 6, 2022 report and accepted by West Shelby Water District (West Shelby District) in its January 19, 2022 comments to the Commission Staff Report. The February 24, 2022 Order required West Shelby District to file within 20 days of the entry date of that Order new tariff sheets reflecting the approved rates. When reviewing West Shelby District's updated tariff, the Commission noted that although the Order listed a 5-inch meter West Shelby District does not have a 5-inch meter in its revised tariff.

Based upon its review of the August 13, 2021 Order in Case No. 2021-00240,¹ West Shelby District's tariff, and the application in this current case,² the Commission

finds that West Shelby District's rate schedule contained in Appendix A to the February 24, 2022 Order should be stricken and replaced with the Appendix to this Order that contains the corrected rate schedule for West Shelby District.

IT IS THEREFORE ORDERED that:

- 1. The Commission opens this case for the limited purpose of addressing the new evidence regarding West Shelby District's rate schedule.
- 2. The rate schedule contained in Appendix A to the February 24, 2022 Order is stricken and replaced with the rate scheduled contained in the Appendix to this Order.
- 3. All other provisions of the February 24, 2022 Order not otherwise in conflict with this Order remain in full force and effect.
 - 4. This case is closed and removed from the Commission's docket.
