ORDER

On July 13, 2021, the city of Jackson (Jackson) filed with the Commission a motion for an extension of time in which to respond to Commission Staff's requests for information contained in Appendix B to the Commission's Order entered June 21, 2021. As grounds for its motion, Jackson explained that the Jackson Municipal Waterworks has only two employees who have regular office duties with vacations scheduled, and one of the employees is pregnant and requires leave for medical appointments. Jackson explained that the water department did not have adequate staff to prepare the filing by the July 23, 2021 deadline.

The Commission finds good cause to grant an extension until August 20, 2021, to respond to discovery based upon the availability of staff to respond and that the extension will not cause unreasonable delay. The Commission also finds good cause to extend the other deadlines remaining in this matter accordingly. Therefore, the amended procedural schedule is attached as an Appendix to this Order.

IT IS THEREFORE ORDERED that:

1. Jackson's motion for extension of time is granted.

2. The procedural schedule set forth in the Appendix to this Order, which is attached hereto and incorporated herein, shall be followed.
