RENEWED MOTION TO DISMISS

Comes now Jackson Energy Cooperative Corporation ("Jackson Energy"), by and through the undersigned counsel, and hereby files this renewed motion to dismiss this matter.

This matter arises from a complaint filed by Rosemary Spicer against Jackson Energy alleging, in sum, that Jackson Energy has refused to provide electric service to a structure on her property. Jackson Energy responded to the complaint in a timely manner and noted that it was unable to provide the service inasmuch as Ms. Spicer's wastewater disposal system did not comply with local regulations and therefore, the appropriate release originally granted by the Kentucky River District Health Department had been revoked.

On September 2, 2021, the Commission entered an order directing Ms. Spicer to file a response to Jackson Energy's answer and further directing her to provide documentation from the Kentucky River District Health Department documenting that the

release for electric service remains in full force and effect. That order also directed Jackson Energy to file documentation in support of the revocation of the release. That documentation was filed on September 2, 2021, the same day the order was entered. However, Ms. Spicer filed no response to Jackson Energy's answer, nor did she file the documentation required by the Commission.

On November 2, 2021, the Commission entered an order requiring Ms. Spicer to, within twenty days, file documentation from the Kentucky River District Health Department indicating that the release for electric service that was originally filed on April 29, 2021, remains in full force and effect. A review of the record indicates that Ms. Spicer has not complied with the Commission's order of November 2, 2021, and in particular, she has not filed the required documentation from the Health Department.

Given Ms. Spicer's failure to prosecute this action, and further, given her failure to comply with the Commission's order, Jackson Energy now moves that this matter be dismissed with prejudice.
