COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION
TO KENTUCKY POWER COMPANY

Kentucky Power Company (Kentucky Power), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on November 29, 2021. The Commission directs Kentucky Power to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made, and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a

governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Kentucky Power shall make timely amendment to any prior response if Kentucky Power obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Kentucky Power fails or refuses to furnish all or part of the requested information, Kentucky Power shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Kentucky Power shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Kentucky Power's Application, Exhibit 2, page 2.
 - a. Explain whether the "facilities" include the meters currently used by the customers.

b. Explain whether Kentucky Power and Big Sandy Rural Electric Cooperative Corporation (Big Sandy RECC) discussed selling the meters at net book value.

2. Refer to Kentucky Power's Response to Commission Staff's First Request for Information (Staff's First Request), Item 4.

a. Provide the estimated costs associated with extending Kentucky Power's current distribution lines to serve these customers.

b. Explain whether Kentucky Power is unable to serve these customers without additional poles.

3. Refer to Kentucky Power's response to Staff's First Request, Item 5.

a. Explain how the customers will receive retail electric service during the estimated 10–12 week timeframe.

b. Explain whether the customers will experience disruptions of retail electric service during the 10–12 week timeframe and how Kentucky Power plans to mitigate these disruptions in service.
