March 1, my internet goes up to 141.00 a month! For just internet. I cannot pay that! I told them I cannot pay that. They suggested I go online for govt assistance to help pay my bill. I am not eligible for that. I asked to downsize to the smallest cheapest package they had. They told me... \$80 a month. That's just for internet. We have no cable tv in my house, it was too expensive years ago so we let it go. There is no competition in this area.

March 1, we will have no internet. I told them to disconnect it. I called ATT. They have a pretty good plan but told me "not available" in my area. Now my brother in law a half mile from me has it, and a friend a half mile on out the road has it. They couldn't explain, but told me no, I cannot get it.

Verizon....good package but "not available" in my area.

T mobile...." not available" in my area...

I've even looked into off the wall internet's. Guess what.. I live a few tenths of a mile from the city limits of Princeton in Caldwell County Ky, my area might as well be known as TIM BUCK TO KY.

I would welcome Kenergy internet options!!! Please get us some options. I know others further out that don't even have the media com option. They have 0.

We have a Verizon wireless hotspot with unlimited data, however after 30 gigabytes of data used, the speed slows down and we are unable to use internet. After 3 days of NTI schooling, we used all 30 gigabytes and were unable to complete the required schooling for today's NTI snow day.

Last year, while the school year was mostly virtual, I had to take my child out of public schooling and homeschool him because we did not have the available internet in our area.

My child is in first grade and as he grows older, internet will be required to complete his public school homework.

Dear Commission: I am sending my support of our local Kenergy Co-op and their application to create a fiber internet network for our region and their customers. I do live in Kenergy's service district out in the country, Henderson County, and have been pleased with their service for 27 years now. I have also tried for years to get decent internet service through multiple carriers and each time the answer is "no, we don't come down that road". We have also tried satellite dishes on our roof which only increase in cost every year and the service got worse every time. The last satellite carrier we had was charging over \$120 per month and we got 4 Mbps upload speed for our money! We have canceled all of that and now use the hotspot data from Verizon. So, please, please approve a new method!

The other issue with not having faster internet has come during Covid and more recently and ice and snow event. I am a former school board member for Henderson County Schools and during 2020 when we were forced to send kids home to do NTI school lessons, we learned very quickly that a large portion of our families out in the county did not have fast enough (or even access to any) internet to allow virtual classes! Like many other counties in KY we resorted to parking buses with internet at remote locations or allowing anyone in our school parking lots access to the school internet so parents could come and park and upload school work. What a crazy way to do school and it often left children with no (or affordable) internet to participate in the daily classrooms and left them feeling even more isolated!

So if you do not find my personal plea enough to convince you to approve Kenergy's application, please, please, please do it for our kids!!

To whom it may concern,

I am writing in support of Kenergy creating a fiber internet network for its customers in my county.

I reside in McLean County, specifically Calhoun. As a healthcare provider, mother of two (one school aged), and a fan of streaming entertainment, internet access is quite important to me. Right now, no dependable source of internet is available to me. We rely on a "hot spot" form of mobile WiFi through our cellular carrier, but the quality is dependent on many factors over which I have no control.

Recently our school district had NTI (non-traditional instruction) days to keep the children learning while at home due to weather. Unfortunately, my son could not access some of his educational content because the bandwidth and amount of data was not compatible with what our hot spot could do. These NTI days are occurring more commonly with the current pandemic and unpredictable weather. However, it is very limited when the internet is not reliable or capable.

My husband relies on communication lines as director of the EMS services. While they can and do rely on radio services, some of their forms and paperwork to continue their jobs and keep their credentialing up to date rely on submitting online files and such. They have issues with their internet service being shoddy, as well.

I believe establishment of a more reliable internet source will be so beneficial to education, business, and less importantly, happiness. Please consider allowing Kenergy to establish this much needed service in our communities and regions.

Good Morning,

Curtis Dame, the judge executive of McLean Co Kentucky made a post regarding comments for the application of a high-speed broadband system for McLean Co. Kentucky. We operate a \$13+ million (gross sales) farm equipment parts business at the address below, and my family lives at this same address at the bottom of this email.

We don't currently have a reliable form of high-speed internet at our business location approx. 5 miles north of Calhoun, KY. We currently have the Watch Communications (formerly Q-Wireless) network which is very slow and unreliable, I just checked the speed and its 0.63 MB/S download and 0.91 MB/S upload (at 9.23AM today). That's bad enough, but it's usually MUCH slower later in the day and we have had recent outages which were many hours in length. We often try to send 40-100+ MB files (product drawings or marketing materials), and they often time out because of a break in the connection. We have tried Exceed satellite internet (we still have the dish outside), but it was very unreliable for our business and we cancelled it. Our internet is often bad enough that we sometimes have to drive to Owensboro to find a wireless hotspot at a restaurant (such as Panera Bread which has 10-15 MB/S speeds) , to send larger files.

To make it worse, we don't have good cellphone signal at our business, 1-2 bars at best and it is not 5G which is not available here, so we can't use our phones for acceptable internet speed.

Its hard to imagine that a business like ours in McLean Co. KY doesn't have a reliable and fast internet network we desperately need it, please do anything you can to expedite this service to help our business and our community.
