COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO CORINTH WATER DISTRICT

Corinth Water District (Corinth District), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on February 11, 2022. The Commission directs Corinth District to the Commission's July 22, 2021, Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the question to which the response is made, and shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the

response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Corinth District shall make timely amendment to any prior response if Corinth District obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Corinth District fails or refuses to furnish all or part of the requested information, Corinth District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Corinth District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Confirm that Corinth District consulted an attorney before committing to the Lease Agreement, and explain ultimately who approved the commitment.
2. Explain the circumstances that led Corinth District to determine that the financing was not subject to Commission approval.
3. Refer to the Application, page 2. Explain what steps Corinth District intends to take or has taken to prevent violations of KRS 278.300 in the future.

4. Refer to the Application, page 6, paragraph 17. Explain specifically to which regulation and to what extent Corinth District is seeking a deviation.

5. For each member of the Corinth District Board of Commissioners, provide the date the commissioner last attended training conducted by the Commission; state whether the training was in person or virtual.
