ORDER

South Kentucky Rural Electric Cooperative Corporation (South Kentucky RECC) is hereby notified that it has been named as a Defendant in a formal complaint filed on March 11, 2022, a copy of which is attached to this Order as an Appendix. By Order dated March 30, 2022, complainants were requested by the Commission to file a copy of their bills at issue, which they filed on April 15, 2022, and are attached to this Order as an Appendix.

Pursuant to 807 KAR 5:001, Section 20, South Kentucky RECC is HEREBY ORDERED to satisfy the matters complained of or file a written answer to the complaint within ten days from the date of entry of this Order. South Kentucky RECC's answer shall include:

A statement regarding whether complainants have requested a meter test
and whether South Kentucky RECC performed a meter test.

- A copy of any meter test results pertaining to any meters used at the property described in the complaint.
- All correspondence between South Kentucky RECC and complainants that pertains to the electric bills discussed in the complaint in this case.

The Commission directs South Kentucky RECC to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. In the Commission's March 16, 2020 Order in Case No. 2020-00085,² the Commission provides instructions for filings in non-electronic cases, insofar that parties of non-electronic cases may file one original document with no copies, or send an electronic mail message with an electronic copy of the document to the Commission and to parties to the matter. Any electronic email filed in this manner should be sent to PSCED@ky.gov, and each message should include the case number in the subject line of the message and a read receipt to ensure the Commission received the message and documents. A party filing a paper containing personal information shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.
