ORDER

On June 15, 2022, Bluegrass Water Utility Operating Company, LLC (Bluegrass Water) filed a motion to for an extension of time in which to reply to the supplemental request for information from the Commission Staff, which was previously due to be filed no later than June 16, 2022. Bluegrass Water requested that it be granted an additional week to file their response, which would change the procedural due date for its response to June 23, 2022. Bluegrass Water stated in its motion that it was making every effort to respond to the supplemental request for information in a timely fashion, but that it needed additional time in which to gather all of the information requested and prepare its response.


Due to its need for additional time in which to file its response to the supplemental request for information, Bluegrass Water also requested an extension of time in which it is required to either request a Public Hearing or in the alternative submit a request for the matter to be decided on the written record, which is currently scheduled for June 23, 2022. It requested that this date be changed to June 29, 2022.

The Commission finds that good cause has been shown to grant Bluegrass Water's motion. The Commission notes that the continuances will not result in prejudice to any party. The Commission establishes a new due date for Bluegrass Water to file its response to the supplemental request for information from Commission Staff, and it also establishes a new date by which Bluegrass Water must decide to either request a Public Hearing on the matter or in the alternative submit the matter to the Commission for decision based on the written record.

IT IS HEREBY ORDERED that:

1. Bluegrass Water's motion for extension of time is granted.
2. Bluegrass Water shall submit their response to the Commission Staff's supplemental request for information no later than June 23, 2022.
3. The last day for Bluegrass Water to request a Public Hearing or submit a request for the matter to be decided upon the written record shall be changed to June 29, 2022.
