



### NOTICE:

On February 28, 2022, Brandenburg Telephone Company filed revisions to its local exchange tariff to delete its CATV Pole Attachment language and will concur instead with Section 18 of the Duo County Access Tariff 2A. This tariff filing was made pursuant to 807 KAR 5:015 which, among other things, establishes specific criteria and procedures for obtaining access to utility poles within the Kentucky Public Service Commission's jurisdiction. Consequently, the proposed new tariff Schedule 18 reflects updated terms and conditions covering access and attachments to poles. We do not propose any changes to attachment rates themselves.
