On June 23, 2022, the Commission issued an Order suspending the proposed rates and establishing a procedural schedule for Water Service Corporation of Kentucky's (Water Service Kentucky) application for a general adjustment of rates and for a Certificate of Public Convenience and Necessity. The Order stated that the application was accepted for filing as of June 13, 2022, and, in accordance with KRS 278.180, the earliest date that Water Service Kentucky's proposed rates could be effective to be July 13, 2022. The Order further stated that an investigation would be necessary to determine the reasonableness of the proposed rates, and, in accordance with KRS 278.190(2), suspended the rates for six months, up to and including December 10, 2022. The December 10, 2022 date was incorrect because it is five months from the July 13, 2022 effective date. The Commission finds that the June 23, 2022 Order should be amended to reflect that the suspension date is January 13, 2023, which is six months after the July 13, 2022 effective date.

Finding that the June 23, 2022 Order shall be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. The suspension date of December 10, 2022, is stricken and is replaced with January 13, 2023.

2. All other provisions of the Commission's June 23, 2022 Order that are not in conflict with the terms of this Order shall remain in effect.
