RE: Informal Conference of July 13, 2022

Pursuant to an Order issued on July 11, 2022, a virtual informal conference (IC) was conducted on July 13, 2022, at 1:00 p.m. Eastern Daylight Time. Representatives of Kentucky Frontier Gas, LLC (Kentucky Frontier) participated in the virtual conference with Commission Staff. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Kentucky Frontier's proposed modification to their Gas Cost Recovery (GCR) rate report, which would change the GCR mechanism from a unified rate to a bi-furcated rate to reflect the high gas costs paid by Kentucky Frontier to one supplier. The supplier is the sole gas supplier to an area previously served by Public Gas, which was subsequently acquired by Kentucky Frontier. In the GCR rate report, Kentucky Frontier provided the difference between the unified rate and a bifurcated rate.

Kentucky Frontier expects to file a request for a declaratory order on whether the supplier is subject to the Commission's jurisdiction, which would include Commission jurisdiction over the supplier's rate.

Commission Staff discussed procedural issues regarding the request and the GCR process, and the timeline needed to separate the rates.

There being no further discussion, the IC was then adjourned.
