ORDER

On March 20, 2023, Big Rivers Electric Corporation (BREC) filed a request for a decision on the record. In response, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), an intervenor in the matter, requested an opportunity to file a brief to present the Attorney General's position on the issues presented.

The Commission finds a briefing schedule to be appropriate and grants the request of the Attorney General to brief the matter. Providing the parties with the opportunity to file briefs will afford the parties the opportunity to present their respective positions on the issues presented and assist the Commission in determining whether a hearing will be necessary. The Commission reserves the right to schedule a hearing at a later date, if necessary. The Commission reminds the parties that only issues addressed in the initial briefs should be discussed in the response briefs.

IT IS HEREBY ORDERED that:

1. The Commission grants the request of the Attorney General and finds that briefs from each party shall be filed in accordance with the schedule as set out in this Order.


2. The parties shall file the initial briefs by April 12, 2023.

4. Nothing in this Order shall be construed as preventing the Commission from issuing further Orders in this matter.

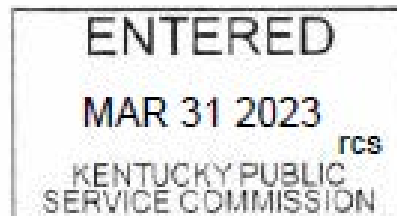
