RE: Informal Conference of November 21, 2024

Pursuant to a Staff Notice issued on November 11, 2024, an informal conference (IC) was conducted on November 21, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss the Qualified Infrastructure Improvement Plan (QIIP) required from Western Fleming County Water District (Western Fleming District). Western Fleming District has been timely filing its monthly surcharge activity and water loss reports but has not filed a QIIP.

Western Fleming District was ordered to file its QIIP 120-days after the Commission's Order entered on September 19, 2022. Previous informal conferences were held with Western Fleming District on March 30, 2023 and September 5, 2024, to discuss the filing requirement for the QIIP. Staff reiterated the importance of filing the QIIP and compliance with the Commission's Orders to Western Fleming District's Board of Commissioners. Western Fleming District stated it planned to file a request to extend the deadline and will be preparing the QIIP as soon as possible.

There being no further discussion, the IC was then adjourned.
