RE: Informal Conference of March 30, 2023

Pursuant to a Staff Notice issued on March 3, 2023, an informal conference (IC) was conducted on March 30, 2023. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss to discuss the water loss surcharge reporting requirements pursuant to the Order issued on September 28, 2022. Commission Staff discussed the monthly surcharge activity reports, monthly water loss reports, and annual reports required from Western Pulaski County Water District (Western Pulaski District). Western Pulaski District reported it had been collecting its surcharge since January of 2023. Commission Staff requested that Western Pulaski District file the appropriate monthly reports to date into the case file.

Commission Staff further discussed the Qualified Infrastructure Improvement Plan (QIIP) previously filed by Western Pulaski District on November 11, 2022 and requested the district file a supplement to provide further detail on the information presented in that plan.

There being no further discussion, the IC was then adjourned.
