RE: Duke Energy Kentucky, Inc. Case No. 2022-00372 Filing Deficiencies

The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

- 1. Section 16 (1) (b) (3): New or revised tariff sheets, if applicable, in form complying with 807 KAR 5:011 with an effective date not less than thirty (30) days from the date the application is filed; Schedule L-1, pages 60-63 of 189, incorrectly state: "Effective: August 15, 2021.". The proposed tariff sheets include the proposed change in rates and tariff language changes but do not have a proper effective date that is 30 days more than the date in which the application has been filed.
- 2. Section 17 (4) (b): The present and proposed rates for each customer class to which the proposed rates will apply; (1) Rate TT: Missing late payment charge from 5% to 2.3%; (2) Rate OL-E: Missing late payment charge from 5% to 2.3%; (3) Rate LED: "220W Standard LED-BLACK" has Lumens different from the tariff; (4) Rate LED: "50W Traditional LED-BLACK" has Lumens different from the tariff; (5) Rate LED: Missing rate "50W Sanibel LED" @ 6,000 Lumens; (6) Rate SC: The Proposed Applicability is missing language from the proposed tariff sheet in Schedule L-1, page 85 of 189 and the redlined version in Schedule L-2.2 page 73 of 152. "This rate schedule terminates December 31, 2026."; (6) Customer Notice Page 1 of 6, Section referring to page 41 of Proposed Tariff (Time of Day Rates), Energy Charge per kWh; (7) Winter on Energy Charge is missing altogether from Notice. It's present in the same section of the Redlined copy of the Tariff in Section L-2.2 and it's marked as being increased; (8) Customer Notice Page 2 of 6, Section referring to page 64 of Proposed Tariff (LED Outdoor Rates), First Table; (9) The Proposed Changes section of the table is instead labeled Current Charges.
