This is to provide the Commission with informal notice that Kentucky Utilities Company and Louisville Gas & Electric Company (“the Companies”) plan on filing an application for approval of the retirement of electric generating units in accordance with Senate Bill 4 which was passed in the 2023 General Assembly. Although I am copying counsel for all parties in Case No. 2022-00402, the Companies will be filing the application in a separate case. The Companies plan on providing formal notice no later than April 10, 2023. The Companies plan on filing the application itself no later than May 10, 2023. Given Senate Bill 4’s 180-day deadline, this would allow for a decision on the proposed retirements by the end of the current procedural schedule in Case No. 2022-00402. Thanks very much.
