The Commission, on its own motion, finds that the procedural schedule amended on May 18, 2023, should be further amended to allow Commission Staff to issue additional requests for information and to extend the date to file the Commission Staff's Report from June 1, 2023, to July 28, 2023.


The procedural scheduled entered on February 16, 2023, was amended on May 18, 2023, in conjunction with the Commission's approval of Letcher County Water and Sewer District's (Letcher District) request for an extension of time to respond to Commission Staff's Second Request for Information (Staff's Second Request). On May 15, 2023, Letcher District filed supplemental responses to Staff's Second Request with revised Schedule of Adjusted Operations, revised Operating Revenues and Operating Expenses, and revised Revenue Requirement calculations, which were based on Letcher District's amended annual report.

The revisions to key financial information require Commission Staff to conduct additional discovery so that Commission Staff recommendations are based on accurate information containing in the revisions. For that reason, additional time is required to process this proceeding.

IT IS THEREFORE ORDERED that:

1. The date for filing Commission Staff's Report established in the May 18, 2023 amended procedural schedule is stricken.
2. The amended procedural schedule set forth in the Appendix to this Order shall be followed.
3. All other provisions of the February 16, 2023 procedural schedule and May 18, 2023 amended procedural schedule not in conflict with this Order shall remain in effect.
4. The Commission does not look favorably on motions for continuances. Accordingly, future motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
