ORDER

On November 3, 2023, Big Sandy Rural Electric Cooperative Corporation (Big Sandy RECC), pursuant to the amended streamlined procedure established in Case No. 2018-00407,¹ tendered an application seeking an adjustment in its rates. On November 20, 2023, the Commission filed an Order finding the application deficient in one area and directed Big Sandy RECC to file notice once the deficiency was cured. Big Sandy RECC responded on November 29, 2023, with a request to withdraw its application stating that after review of its financial position that it intends to file a full rate case.

Based on the request to withdraw the application and being otherwise sufficiently advised, the Commission finds that Big Sandy RECC established good cause to withdraw its application, and therefore this proceeding should be dismissed.

IT IS THEREFORE ORDERED that this case is dismissed and is removed from the Commission's Docket.
