1. All issues raised in Case No. 2023-00320 shall be transferred to and consolidated into Case No. 2023-00263.





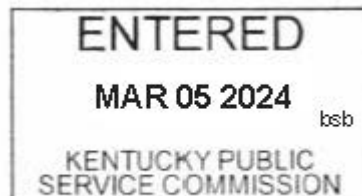
