ORDER

On December 6, 2023,<sup>1</sup> Rattlesnake Ridge Water District (Rattlesnake Ridge District) filed its application with the Commission requesting an adjustment to its water rates pursuant to 807 KAR 5:076. The Commission established a procedural schedule by Order dated December 21, 2023, that, among other things, required Commission Staff to file with the Commission and serve upon all parties of record a written report (Commission Staff's Report) containing its findings and recommendations regarding Rattlesnake Ridge District's requested water rate adjustment, no later than April 23, 2024.

On February 8, 2024, the Commission amended the procedural schedule to add in a date for a field review at Rattlesnake Ridge District and change the dates that Rattlesnake Ridge District responses to request for information were due. On March 27, 2024, the Commission ordered Rattlesnake Ridge District to respond to all outstanding requests for information within ten days of the date of service of the Order.

The Commission, on its own motion, finds that the procedural schedule established on December 21, 2023, and as amended on February 8, 2024, should be amended again

<sup>1</sup> Rattlesnake Ridge District tendered its application on November 20, 2023. By letter dated November 21, 2023, the Commission rejected the application for filing deficiencies. The deficiencies were subsequently cured, and the application was deemed filed on December 6, 2023.

to allow for additional time for Commission Staff to complete the Commission Staff's Report. The additional time is needed due to Rattlesnake Ridge District's delay in response to Commission Staff's Second Request for Information.

IT IS THEREFORE ORDERED that:

1. The procedural schedule established on December 21, 2023, and February 8, 2024, is amended.
2. Commission Staff's Report shall be filed on May 21, 2024.
3. All provisions of the Commission's December 21, 2023 and February 8, 2024 Orders not in conflict with the provisions of this Order shall remain in effect.

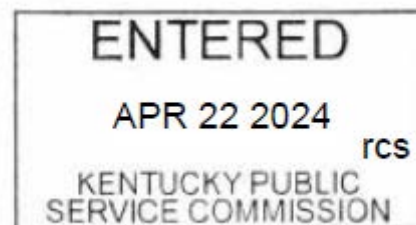
