RE: Informal Conference of January 10, 2024

Pursuant to Staff Notice issued on December 28, 2023, an informal conference (IC) was conducted on January 10, 2024. Attached is a copy of the attendance roster. This IC was held concurrently with the IC in Case No. 2023-00397, Electronic Application of Kentucky Utilities Company for an Order Authorizing the Issuance of Indebtedness.

The purpose of the IC was to discuss issues pertaining to Louisville Gas and Electric Company's (LG&E) filing for an Order Authorizing the Issuance of Indebtedness. This IC was scheduled at the request of LG&E in their motion filed on December 13, 2023. Representatives of LG&E presented information relating to their application with explanation of their proposal and answered questions from Commission Staff about the differences in this filing from previous requests for indebtedness that they felt required additional explanation, along with other areas where questions were needed to offer clarification to the application. LG&E presented a slideshow for staff's consideration that contained information that spoke to various areas of the application, some of which contained confidential information. Staff requested that the full slideshow be submitted on the record with a petition for confidential treatment for the specific parts that contained sensitive information. All parties agreed.

There being no further discussion, the IC was then adjourned.
