ORDER

On March 1, 2024, Pleasant Valley Solar Farm, LLC (Pleasant Valley Solar) filed a notice of intent (NOI) to file an application for a Construction Certificate for an approximately 125- megawatt merchant electric solar generating facility to be located in Lyon and Caldwell counties, Kentucky. A renewed NOI was filed on September 1, 2024.

On February 10, 2026, correspondence was filed into the record requesting that Pleasant Valley Solar file a status report within 30 days because the NOI that was filed for the case had expired. On March 2, 2026, Pleasant Valley Solar filed a notice that it was withdrawing the NOI to file an application. Pleasant Valley Solar requested that the case be closed and removed from the Siting Board's docket.¹ Since Pleasant Valley Solar withdrew its NOI, the Siting Board finds the case should now be closed and removed from the docket.
