**REQUEST:**

Based on the information provided in response to Item 4 above, calculate the Complainant's bills, for each billing period, based on a residential rate for the entire building from the date the Complainant's request was made until the date of this request. Consider this an ongoing request that should be updated each billing period. In the response, include the actual amount billed to Complainant as compared to the calculated amount as requested.

**FIFTH SUPPLEMENTAL RESPONSE:**

Please see STAFF-DR-01-005 5<sup>th</sup> Supplemental Attachment for a recalculation of the Customer's bill for a residential rate as updated for June. This recalculation includes all aspects of the customer's bill: electric, gas, other charges and credits, and taxes.

This data request asks the Company to use the data provided in Item 4 to calculate bills based on the residential rate. The only data requested in Item 4 was "energy used, per kWh". As such, prior bill calculations only included the electric charges. However, based on communication from Mr. Drohanes and in the spirit of discovery, the entire bill has now been recalculated based on the residential rate.

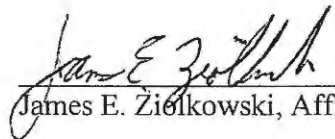
The Company will continue to update this request each billing period.

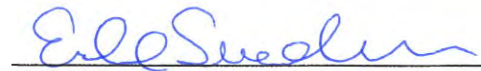
