RE: Informal Conference on December 13, 2024

An informal conference (IC) was conducted on December 13, 2024. Attached is a copy of the attendance roster. The IC was a continuation from the IC held December 6, 2024.

The purpose of the IC was to follow-up on the statutory deadline with the parties. The parties were able to consult with the respective entities that each represented. Upon meeting and Staff asking if everyone had had time to discuss the issues related to procedure and the shortened timeline, Duke Energy Kentucky, Inc. stated that the utility intended to withdraw its application. The utility stated that it was going to restart the statutory clock by refiling, but after notice was published again.

In addition, although Staff could not speak for the Commission, the parties expressed a desire to incorporate the current case record in the new case and to the extent possible, asked Staff to assist the parties in a smooth transition to the new case, including intervention and pro hac vice admittance. All parties agreed that the new case would be a good candidate for expediated treatment based on the fact that the current case was set for hearing in January 2025.

There being no further discussion, the IC was then adjourned.
