<u>ORDER</u>

This matter arises upon Big Sandy Rural Electric Cooperative Corporation's (Big Sandy RECC) motion for an extension of time to file its Cost Allocation Manual (CAM).¹

On June 20, 2025, the Commission issued a final Order finding that Big Sandy Forestry, LLC was an affiliate of Big Sandy RECC.² The Commission also ordered Big Sandy RECC to file proof of compliance with KRS 278.2213 and KRS 278.2207 within 60 days of the Order.³

On August 15, 2025, Big Sandy RECC filed a motion requesting a 60-day extension to file its CAM. In support of its motion, Big Sandy RECC stated that it was working diligently to comply with KRS 278.2213 and KRS 278.2207.⁴ Big Sandy RECC further stated that it had drafted the CAM but Big Sandy RECC's Board of Directors (Board) would not be able to approve the CAM until August 28, 2025, at the earliest.⁵ Big

Sandy RECC stated that it would like to wait and file the CAM until after it has been approved by Big Sandy RECC's Board.⁶ Big Sandy RECC further stated that if its Board approves the CAM at the August 28, 2025 meeting, it would file the CAM prior to the 60-day requested extension.⁷ Big Sandy RECC filed the CAM on September 3, 2025.⁸

Having reviewed the case and being otherwise sufficiently advised, the Commission finds that Big Sandy RECC has provided good cause for the 60-day extension. Therefore, the Commission finds that Big Sandy RECC's motion for a 60-day extension should be granted.

IT IS THEREFORE ORDERED that Big Sandy RECC's motion for a 60-day extension to file proof of compliance with KRS 278.2213 and 278.2207 as ordered in the Commission's June 20, 2025 Order is granted.
