RE: Informal Conference of December 17, 2024

Pursuant to an Order issued on December 4, 2024, an informal conference (IC) was conducted on December 17, 2024. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss the Application filed in this matter to make improvements to the Bellefonte Station. Nicholas Koehler went through the PJM Interconnection, LLC (PJM) slides provided in the Application, Exhibit 8. He discussed how the options to address thermal violations and issues with overdutied circuits. According to Mr. Koehler, there are economies of scale when you can combine baseline projects required by PJM and other supplemental projects at the same time. Baseline projects have a required in-service date while the Supplemental projects have projected in-service dates. There are several lines coming into the Bellefonte Station so the number of customers affected by issues at the Station is greater than would be in other areas.

Daniel Barr reviewed several maps with the IC participants. The maps were the ones requested as part of Staff's First Request for Information, the responses to which were filed in the record after the IC.

Tanner Wollfram discussed the financing for the project. As with the other case, Case No. 2024-00344, Kentucky Power did not expect to request approval for additional indebtedness.

There being no further discussion, the IC was then adjourned.
