RE: Informal Conference of November 14, 2025

Pursuant to Commission Staff's Notice issued on November 10, 2025, an informal conference was held on November 14, 2025, by video conference in the above-referenced matter.

The purpose of the informal conference was to discuss issues presented in this matter, including Natural Energy Utility Corporation's Gas Cost Recovery rate report filings and the filing requirements for confidential materials. Staff members and representatives of NEUC discussed treatment of gas sales to special contract customers, using updated gas costs prior to notice of implementation of new rates, and whether the new rate is applied to usage occurring or to usage billed after the rate is put into effect.

Staff discussed the need to file a motion if confidential treatment is sought for any material other than personal information as defined in 807 KAR 5:001, Section 4(10). Staff stressed that it must be clear from any redaction of personal information the type of information that was redacted.

Staff told representatives of NEUC that they could contact the Commission's Executive Director with questions. Staff also stated that before a case is filed, NEUC could reach out to staff including in Financial Analysis with questions about filings, but that once a case is initiated, communications should to counsel for NEUC and the Commission's legal staff.

There being no further discussion, the informal conference was then adjourned.
