SALT RIVER ELECTRIC COOPERATIVE CORP. ANSWER TO
COMPLAINT

1. Salt River Electric Cooperative Corp (SREC), for its Answer to the Complaint, states as follows:

Due to all of our recognized vendors no longer stocking non-LED outdoor lighting, SREC is not able to procure non-LED lighting and/or replacement bulbs resulting in the cooperative's inability to replace any Sodium Vapor light.

As a result and out of necessity, SREC has filed a tariff with the Kentucky Public Service Commission (Case 2025-00069) to revise its Outdoor Lighting and Commercial Lighting Rate Schedules to reflect our inability to continue to offer outdated lighting options or bulb replacement.

SREC has located approximately six (6) Sodium Vapor bulbs in one of its warehouses and will agree to utilize what is currently in stock, should Ms. Burnett still want the Sodium Vapor bulb light. However, since filing her Complaint, Ms. Burnett has requested the removal of her exterior light, and SREC has complied.
