ORDER

On January 24, 2025, the Commission ordered East Logan Water District (East Logan District) to:

On or before August 30, 2025, East Logan District shall file an application for a general rate adjustment pursuant to 807 KAR 5:001, Section 16, or an application for an alternative rate adjustment pursuant to 807 KAR 5:076, or in the alternative, file a formal motion with a detailed analysis of its rates and revenues explaining the reasons why no modifications are necessary.¹

On August 30, 2025, East Logan District filed a motion to accept analysis of revenues and rates in both this case and a new case,² indicating that it sought to forego the filing of a rate adjustment.

The Commission finds that East Logan District has complied with the requirement of the January 24, 2025 Order by filing its August 30, 2025 motion. The remaining relief requested in that motion will be resolved in Case No. 2025-00265.
