## ORDER

On March 21, 2025, the Commission entered an Order conditionally approving and accrediting the water district training program offered by Northern Kentucky Water District (Northern Kentucky District) and Stoll Keenon Ogden PLLC scheduled to take place on April 3, 2025, titled *Northern Kentucky Water Training 2025* (Training Program) to satisfy up to six hours of annual training described by KRS 74.020(6) and (7). Following the training, Northern Kentucky District submitted materials indicating, among other things, that the Training Program was conducted as scheduled without material change, the name and district of each attending water district commissioner, whether the water district commissioner attended remotely or in person, and the number of hours that each water district commissioner attended. Having reviewed the materials submitted by Northern Kentucky District and being otherwise sufficiently advised, the Commission finds that the Training Program should be granted final approval.

## IT IS THEREFORE ORDERED that:

- 1. The Training Program is approved and accredited for a maximum of six hours of water district management training for water district commissioners seeking to satisfy the annual training requirements set forth in KRS 74.020(6) and (7).
- 2. The water district commissioners listed in Tab 3 of the Notice of Filing, filed April 7, 2025, shall receive six hours of water district management training to satisfy the annual training requirements.
- 3. The Training Program may not be used by water district commissioners seeking to satisfy any portion of the initial training requirement for water district commissioners required by KRS 74.020(8).
  - 4. This case is closed and removed from the Commission's docket.
