ORDER

On March 31, 2025, Kentucky Power Company (Kentucky Power) filed a motion for an extension of time to respond to Commission Staff's First Request for Information. Kentucky Power stated that the utility only had four business days to respond to the request and although it was able to file some responses, it would need more time to file complete responses to every request.<sup>1</sup> Kentucky Power noted that it requested an extension until April 3, 2025; however, Kentucky Power would try to file complete responses prior to that date.<sup>2</sup>

Having considered the motion, the Commission finds that Kentucky Power has provided good cause to grant an extension. While recognizing that an application for approval of indebtedness pursuant to KRS 278.300 has a 60 day statutory deadline, the Commission agrees that four business days to respond to 27 individual requests for information may be difficult. The Commission appreciates that Kentucky Power did file several responses allowing time for Commission Staff to review the filings.

As a result of the extension, the Commission, on its own motion, will amend the procedural schedule. The Commission will still strive to have an Order issued by the date requested by Kentucky Power in its application.<sup>3</sup> Kentucky Power shall follow the schedule attached to this Order as an Appendix.

IT IS HEREBY ORDERED that:

1. Kentucky Power's motion for an extension is granted.
2. The procedural schedule is amended.
3. The procedural schedule attached as an Appendix to this Order shall be followed.
4. All provisions of the Commission's March 25, 2025 Order that are in conflict with the provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
