The Commission, pursuant to 807 KAR 5:056, Section 3(3), hereby initiates the six-month review to examine the application of the Fuel Adjustment Clause (FAC) from November 1, 2023, through April 30, 2024, of Jackson Purchase Energy Corporation, Kenergy Corp., and Meade County Rural Electric Cooperative Corporation (collectively, Cooperatives or individually Cooperative).

IT IS THEREFORE ORDERED that:

1. Each Cooperative shall individually file with the Commission, on or before July 18, 2025, an affidavit attesting to is compliance or noncompliance with the requirements of 807 KAR 5:056. The Commission directs the Cooperatives to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

2. All documents that each Cooperative filed with the Commission during the period under review pursuant to 807 KAR 5:056, Sections 2(1)–2(4), are incorporated by reference into the record of this proceeding.

3. As set forth in 807 KAR 5:001, Section 4(11)(a), a person requesting permissive intervention in a Commission proceeding is required to demonstrate either (1) a special interest in the proceedings which is not adequately represented in the case, or (2) that the person requesting permissive intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. Therefore, any person requesting to intervene in a Commission proceeding must state with specificity the person's special interest that is not otherwise adequately represented, or the issues and facts that the person will present that will assist the Commission in fully considering the matter. A mere recitation of the quantity of utility service consumed by the movant or a general statement regarding a potential impact of possible modification of rates will not be deemed sufficient to establish a special interest.

4. Any request for intervention must be filed by June 20, 2025.

5. Pursuant to 807 KAR 5:001, Section 8, unless a party granted leave to intervene states its objection to the use of electronic filing procedures in a motion for intervention, the party shall be deemed to have consented to the use of electronic filing procedures and the service of all papers, including Orders of the Commission, by electronic means; the party shall file with the Commission, within seven days of the date of entry of an Order of the Commission granting the intervention, a written statement that the party waives any right to service of Commission Orders by United States mail; and

the party, or the party's authorized agent, possesses the facilities to receive electronic transmissions.

6. The Commission does not look favorably upon motions for continuance. Accordingly, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

7. Witnesses who sponsor schedules, testimony, or responses to requests for information shall participate in person at any hearing scheduled in this matter.
