Hello Team,

I wanted to share my comments on the proposed rate hike for KU/LG&E to be read at tonight's meeting:

I run a small nonprofit that cares for underserved communities in Fayette County. This proposed rate hike not only increases our utilities expenses by almost 12 percent, it cuts into our viability of consistent service. If you approve this request, you are telling your community they do not deserve respect for their hard work and commitment. This proposed increase is an insult.

As a resident within their service area, I would also feel this impact on a financially crippling level. My family does not deserve to have our meager wages stolen because John Crockett is committed to failing upward. I humbly request the executives at this major company pull themselves up by their bootstraps and find their own funds internally instead of leaching off the system. We do not need a 402-MW data center campus in Louisville, we need clean air, affordable utilities, and some scrap of dignity for our so often stereotyped state.

When reflecting upon the demographics of LG&E / KU service areas, this price gouge is not only ill-advised, it's a disservice to our community. At a time when so many are already food insecure, unable to afford health, auto, and home insurance, when finding a consistent 40 hour a week job with benefits has never been more difficult, this massive increase is insulting to even propose. If KU and LG&E can provide consistent, uninterrupted service at a reasonable price serving every paying customer in their service area, then maybe a clear reason for increased price based on improvement of service could be viable if needed and the need transparently proven.

Lexingtonians are sick of these bloated companies once again shuffling the financial burden onto customers. I would suggest the folks at KU consider reducing their executive bonuses as a show of good faith towards the communities they monopolize. This is not only a ridiculous price gouge, but shows a lack of fiduciary responsibility by their strategic planners.

In fact, in the wake of data center proposals popping up at extreme cost to the historic American agriculture industry, Virginia, Colorado, and Washington residents have already voted to remove public officials who did not take a stand against this sort of aggression towards the people they swore to protect.

Bad stewardship comes at a cost, and I would much rather see our community flourish than serve short-sighted private interest. I implore you to do the right thing for all of us.

Shoot down this hike, demand transparency from Crockett and cronies. Prioritize renewable energy as well as the health and financial stability of those who actually live, work and spend here in the Bluegrass.

Simply put, it is not the responsibility of the customer to prop up decision makers who failed to incentivize retention and support from their customer base.

I have not noticed an 11.5% increase in our grid infrastructure or reliability, so why does KU get to demand more from us? We cannot allow these corporations to roll us over. They can ask for a reasonable increase (<2%) or none at all. I am grateful that we at least have regulated utilities in this state so we aren't completely at the whims of corporate greed.

Good afternoon,

I am a resident of Lexington, Kentucky, writing in about the proposed 11.5% rate

increase that KU/LG&E would like to enact on their prices. I am deeply concerned by the idea of such a steep rate increase.

Already, inflation is a major issue facing Kentuckians. Whether it's shopping for groceries or paying rent, our wallets are getting squeezed harder everywhere we go, and we're getting less and less in return for it. I've only lived in Lexington since 2019, and already, I've seen the cost of living increase at a pace that is MILES beyond the typical Lexingtonian's wage increases. It's only gotten worse within the past two or three years.

Still, I understand that not all of this inflation can be helped by the state. For example, there's not much that the state and local governments can do to mitigate or bring down the cost of groceries. You DO, however, have the chance to stop the rate increase being proposed by these power companies. In the Kentucky we live in today, access to electricity is as much a necessary human right as access to food, water, and shelter. And these companies already have a monopoly on a great deal of housing— if not statewide, then certainly in Lexington. If KU and LG&E are the only option for Kentuckians to receive electricity, and the companies are allowed to raise their rates by such a drastic amount with impunity, then in my eyes, that is tantamount to extorting the people of Kentucky. Having to pay more for power, especially with the approach of colder weather in the wintertime, would be disastrous for so many Kentuckian families. And this is a price increase that you, as the state government, have the power to stop. I believe it is your duty to do so.

As a final point, I would like to say that I find this proposed rate increase from KU/LG&E to be even more egregious, in light of the fact that several different companies have begun exploring the possibility of building data centers used to power AI programs throughout Kentucky. These data centers place massive strain on their power grids and would vastly increase the state's energy consumption. Energy generation is historically cheaper than ever. While most of this is driven by the dramatic decrease in costs to renewables despite our current federal administrations policies attempting to curtail them, the truth is that Kentucky Utilities and LG&E have provided no reasonable justification for such an increase in cost. Even the cost of Fossil fuel generation remains relatively steady and certainly is not increasing at the rate the utility is positing for their increased rates.

Kentucky's population has not increased dramatically in the last 12 months, manufacturing output is rising but those manufacturers should be paying commiserate rates to offset that.
