To Whom It May Concern, I'm writing in regards to case no. 2025-00113 which details a rate increase for customers of KU/LGE companies. I'm requesting you to please reconsider? I just ask that you to take in consideration what folks are having to go through in their daily financial lives. Personally, a rate increase would hurt me financially and I know it would hurt most of us. Think of the individuals with lower tier incomes and positions that work day to day to provide for their families in ways that some otherwise wouldn't have struggles as such. I'm talking about the person that comes to work every day, works hard, may be the one that cleans your office for example, that gets paid the minimum amounts for that position, and has to take that paycheck and wonder what bill he/ she is getting paid today? Not to mention, if they will have enough to purchase milk and bread for their family to have a meal with. I ask that you take the time to reach out to these employees and listen to them. Ask them, don't

judge them, but listen and take what they are saying and consider how times are these days and how they would be able to make it with a rate increase. We often preach about needing more trade employees, such as plumber or electrician for example but we never adjust to compensate them accordingly. A plumber or electrician for example starting out would intern under someone for a while, so that compensation would be one that I'm wanting you to consider for example. I'm merely asking you to consider the folks who literally live pay check to pay check. **Think of this, rates go up, expenses increase, but compensation does not!** So, how do you think these folks, such as myself can handle additional expenses? I myself have 5 different meters that I pay for. Some of these are rental properties, I like most will include the cost of your bill into the monthly lease, however, if I were to increase my fee, due to your increase, then said tenant would have to leave the space leased. The snowball effect begins.... You all may be the ones that would have the ability to absorb the increased bill fee, however as asked before... go see the ones that work in the trenches for your company. Spend a minute not counseling them but listening and see their needs and concerns! Your eyes will open and hopefully your hearts will too!

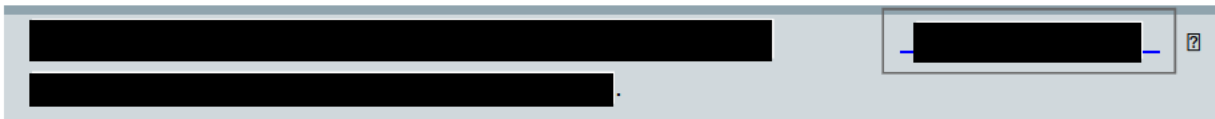

Dear Commissioners,

I am a customer of Kentucky Utilities and I have an array of solar panels on my roof. I am interested in this rate case because of the implications to my investment.

Every month I pay a fixed fee to KU just to access the grid. I'm OK with this, as long as the charge is fair. I use the grid and should, in all fairness, help pay for its maintenance. Where I bristle is at the unequal exchange rates for energy. It does not seem fair to me that my investment in generating capacity is any less valuable than the utility's investment in their generating capacity. They are guaranteed a return on their capital investment. My capital investment is, according to the tariffs, devalued relative to theirs, and constantly a target for them.

Today I pay KU 40% more than they pay me for energy and they propose to reduce it even further. They don't like customers like me, for obvious reasons. However, once we separate the grid from the energy, the market should be fair. I supply electricity to my

neighbors through the grid on hot sunny days, when demand is highest. This is of value to the utility, helping reduce the strain on the system. Since my neighbors are paying KU the same rate I am, KU is making a profit off my investment. If we turned that around and I tried to profit off their investment in generating capacity, it would never pass muster.

I would also add that distributed generation makes for a more resilient grid - just another benefit I provide which goes unrecognized.

I offer this perspective for your consideration in setting fair rates.
