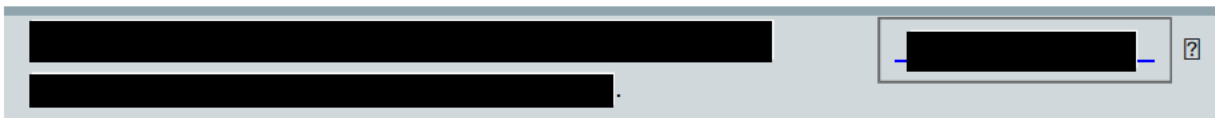

This rate increase is for a gas main and only a gas main. Since there is no increase in administrative costs for small residential users it seems all rate classes should be paying the same rate per ccf for this rider. I have not reviewed the full rate structure for gas distribution and delivery but expect the RS rate already covers all administrative costs for those small users.
