ORDER

On June 10, 2025,¹ McKinney Water District (McKinney District) filed an application with the Commission, pursuant to 807 KAR 5:076 the alternative rate filing procedure, requesting an adjustment to its water rates.² The Commission established a procedural schedule by Order dated June 26, 2025, that, among other things, requires Commission Staff to file with the Commission and serve upon all parties of record a written report (Commission's Staff Report) containing its findings and recommendations regarding McKinney District's requested water rate adjustment, no later than October 22, 2025.

On July 31, 2025, McKinney District submitted its response to Commission Staff's First Request for Information.³ The response mentioned several attachments that were

not included in the filing. After Commission Staff contacted McKinney District, the responses were supplemented on August 12, 2025, with the missing attachments.⁴

Due to the delayed supplemental filing, the Commission finds that the procedural schedule established on June 26, 2025, should be amended to afford Commission Staff additional time to issue a second request for information and prepare and file the Commission Staff's Report. Specifically, the Commission finds that the second request for information shall be issued by September 5, 2025, with a response due date of September 19, 2025, and the date for filing the Commission Staff's Report should be extended to October 31, 2025.

After Commission Staff's Report is filed on or before the amended deadline of October 31, 2025, McKinney District will have 14 days to file a written response to Commission Staff's Report.⁵ If McKinney District does not file written objections to a finding contained in Commission Staff's Report within 14 days after the date of the filing of Commission Staff's Report, it shall be deemed a waiver of all objections to that finding.⁶

IT IS THEREFORE ORDERED that:

- 1. The procedural schedule established on June 26, 2025, is amended.
- 2. The procedural schedule set forth in the Appendix to this Order shall be followed.
