#### ORDER

This matter is before the Siting Board upon a motion that was filed on December 16, 2026, by Barrelhead Solar, LLC (Barrelhead Solar) for approval to amend the procedural schedule that was issued on October 17, 2025.

Barrelhead Solar argued that the procedural schedule should be amended because due to the holiday's multiple members of Barrelhead Solar and Birch Development have planned paid time off during the week between Christmas and New Year's.<sup>1</sup>

Based upon the motion and being otherwise sufficiently advised, the Siting Board finds that the procedural schedule that was issued on October 17, 2025, should be amended. The Siting Board recognizes that holidays do complicate schedules and tries to be accommodating but must also weigh scheduling with the statutory deadline applicable to the matter. Motion's to amended procedural schedules will be reviewed on

- 2. All provisions of the Siting Board's October 17, 2025, Order that are in conflict with provisions of this Order are vacated, and all other provisions not in conflict with the provisions of this Order shall remain in effect.
