- 2. 807 KAR 5:001 Section 12(2)(e): The amount of bonds authorized and amount issued, giving the name of the public utility that issued the same, describing each class separately and giving the date of issue, face value, rate of interest, date of maturity, and how secured, together with amount of interest paid during the last fiscal year; No reported bonds included in the application; however Exhibit 21 of the 2024 Audit note 7 indicates reported revenue bonds. Please provide clarify the information required for these bonds.
