RE: Informal Conference of August 13, 2026

Pursuant to Commission Staff Notice filed August 11, 2026, an informal conference (IC) was conducted on August 13, 2026. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss topics identified in Executive Order 2026-494: specifically, ratepayer protections and project-cost allocation; the status of TeraWulf's initial energy plan; environmental studies; state, local, and school taxes; and TeraWulf's relationship with and engagement of the local community.

The parties confirmed that there had been no material changes to the ratepayer protections and project-cost allocation, tax estimates and commitments, and community-engagement information previously described in the record. TeraWulf provided updates on ongoing and upcoming community engagement that has taken place beyond what was last reflected in the record, an upcoming job fair, an information series with the local paper addressing topics of interest and townhall meetings. TeraWulf also provided status updates regarding its initial energy plan and environmental studies.

TeraWulf agreed to file a courtesy copy of the initial energy plan when it files the plan with Energy and Environment Cabinet (EEC) and the completed environmental studies tentatively within the next week, and to file the Noise Assessment and Air Modeling in the post case record when completed.

There being no further discussion, the IC was then adjourned.
