RE: Informal Conference of August 27, 2026

Pursuant to a Staff Notice issued on August 14, 2026, an informal conference was conducted on August 27, 2026. Attached is a copy of the attendance roster.

The purpose of the informal conference was to discuss the transition, if the acquisition was to be approved, between the Valley Gas Corp. (Valley Gas) and Ohio Valley Gas, Inc.'s (Ohio Valley Gas) purchase gas adjustments. As set forth in the application, Ohio Valley Gas proposed to adopt the Valley Gas tariff in its entirety, including the tariff setting forth the calculation and filing timing for the purchase gas adjustments for natural gas cost recovery.

Sarah Jankowski and Ben Bellamy discussed the elements of the current calculation and walked through the most recent spreadsheets for calculations found in Valley Gas's Case No. 2025-00389. In addition, there was discussion of how Ohio Valley Gas may proceed should they want to change the adopted tariff at a later date. Staff advised that Ohio Valley Gas should follow the guidance of counsel but it may utilize the tariff filing system in some cases or the general filing system, depending on the change to the mechanism being sought.

If the Commission approves the transaction, Staff agreed to send contact information for Commission Staff handling distinct issues such as inspections and obtaining a utility identification number, at a subsequent date. If the transaction was approved, Ohio Valley Gas was encouraged to reach out with any further issues or questions. However, Staff cautioned during the IC that Staff cannot speak for or bind the Commission, which may only speak through its orders.

There being no further discussion, the informal conference was then adjourned.
